Selected Mediation and Facilitation Experience

Ecological Society of America Deliberations on Citizen Science and ESA Implementation

Facilitated deliberations of two collections of academics and environmental professionals to develop consensus recommendations on incorporating citizen science strategies into ecological data gathering and improving implementation of the Endangered Species Act. Resulting articles from these collaborations will be published by the Ecological Society of America in Spring/Fall 2015.
