Keystone Dialogues & Collaboratives

Keystone's carefully crafted process brings together key thought leaders, decision-makers, and influencers who can forge alliances, make decisions, resolve conflicts, and change the trajectory of challenging issues. Using a diverse array of tools customized to each group's needs, Keystone helps advance practical, implementable solutions to meet negotiated goals.

Public Engagement & Outreach

Keystone designs and executes public meetings on every scale — from small focus groups to state and regional outreach — to gather input, share information, and illuminate public policy decisions. Keystone provides process design, facilitation, electronic polling, synthesis, and dissemination of results.

Situation Assessments

Midwest Row Crop Collaborative

Keystone is helping the Midwest Row Crop Collaborative, a diverse coalition of leading companies and conservation organizations, expand agricultural solutions that protect water quality and enhance soil health. The Collaborative, which launched at the 2016 Farm Progress Show, is focused on measuring and delivering improved environmental outcomes through cross-sector collaboration and continuous improvement at a meaningful scale throughout the Upper Mississippi River Basin. Keystone is providing the Collaborative with leadership and assistance as it supports watershed initiatives and other activities to enhance and accelerate the use of environmentally preferable agricultural practices already underway in Illinois, Iowa, and Nebraska.

The Midwest Row Crop Collaborative's founding members include Cargill, Environmental Defense Fund, General Mills, Kellogg Company, Monsanto, PepsiCo, The Nature Conservancy, Walmart, and World Wildlife Fund.





Food Waste

Keystone and the National Consumers League convened a dialogue about the problem of food waste and better strategies for consumer action. The summit, which took place May 11 in Washington, D.C., featured U.S. Secretary of Agriculture Tom Vilsack, Maine Congresswoman Chellie Pingree, and other thought leaders. They discussed initiatives to reduce food waste in the public, private, and civic sectors; innovative approaches for reducing consumer food waste; and strategies to help consumers make better decisions surrounding food waste.

Keystone built on the summit's success by launching Further With Food, an online hub for the exchange of information and solutions that can help realize the national goal of cutting food waste in half by 2030.





Strategic Action Planning Group on Aging

As the Baby Boomer generation ages, it will profoundly reshape every facet of life. From health care to transportation to the workforce, aging presents unprecedented challenges to state agencies, local entities, and businesses alike. In an effort to confront these challenges, Keystone helped Colorado's Strategic Action Planning Group on Aging develop collaborative strategies to help Colorado plan and prepare for this demographic shift.

Keystone worked with the Planning Group's members and committees to explore solutions, reach common ground, and propose a series of recommendations to help the Centennial State prepare from the state level down to local agencies and businesses. Keystone provided the Planning Group with assistance as it developed its strategic plan, drafted the plan itself, and communicated with the public about its urgency and importance.





Next Generation Genetic Technologies

Synthetic biology — the artificial design and engineering of biological systems and living organisms — offers the potential to address a wide array of public health, ecological, and humanitarian challenges. It also raises important questions related to bioethics, environmental impacts and safety. In an effort to address these questions and find paths forward, Keystone led a series of discussions with leaders from academia, industry, civil society, and government sectors on this emerging issue.

Keystone partnered with the Woodrow Wilson International Center for Scholars convened a one-day, multidisciplinary Leadership Summit on Synthetic Biology Stakeholder and Community Engagement for Public Health, Conservation, and Food and Agriculture to discuss priorities for broadening conversations on the potential risks and benefits of synthetic biology. The summit, held in Washington, D.C., brought together more than two dozen key leaders to share experiences, lessons learned, and priorities for engagement. Keystone partnered with Arizona State University (ASU), North Carolina State University and the Expert & Citizen Science Assessment of Science and Technology (ECAST) Network to convene a stakeholder workshop at ASU on public engagement strategies on genetically engineered algae. Keystone also contributed to a series of events on genetic technologies for species conservation hosted by Revive and Restore at the IUCN World Conservation Congress in Hawaii.





Next 100 Coalition

Keystone provided policy insights and facilitation for the Next 100 Coalition — a broad-based effort to ensure our public lands are engaging and serving all segments of the U.S. population. The Coalition brings together leaders from faith-based, civil rights, community, and environmental justice groups to establish a more inclusive approach to management of our nation's parks and public lands over the next 100 years. Keystone supported the Coalition's efforts to work constructively with land management agencies, environmental and nongovernmental organizations, and the public to include perspectives from an increasingly diverse national constituency in the policies, workforce, and culture of those organizations.

Notably, the Coalition helped secure a Presidential Memorandum from President Obama on Diversity and Inclusion in Our National Parks, National Forests, and Other Public Lands and Waters, which provided concrete direction to public land management agencies for ensuring that all people have the opportunity to experience our great outdoors and engage in decisions about how our public lands and waters are managed. Keystone also helped establish and manage Coalition's work groups on policy development and communications; supported Coalition outreach to the U.S. Department of the Interior and the U.S. Department of Agriculture, as well as several federal agencies; and made connections between the Coalition and other environmental organizations.





Enhancing Healthcare Infection Control Assessment & Outbreak Response

Following the recent Ebola outbreak and the needs it highlighted for more robust infection control assessment and response plans, the Keystone Policy Center worked at the behest of the Association of State and Territorial Health Officials and the Centers for Disease Control and Prevention to convene a national effort to identify lessons learned from recent outbreaks and best practices for application going forward. Through a combination of site visits in select states and extensive regional meetings involving cross-sector teams from states and other participating jurisdictions, Keystone designed and facilitated a dialogue to determine effective or promising strategies for optimizing the capacities of public health agencies in responding to infectious disease outbreaks. The discussions and analysis resulted in guidance for national, regional, and state action.
