#### **Project Experience**

## **Keystone Monarch Collaborative**

Jonathan facilitates the Monarch Collaborative, a multi-sector initiative formed to address the declining monarch butterfly migration in North America. The Collaborative's membership includes stakeholders from the academic, nonprofit, agribusiness, grower, and government sectors. Its work is focused on restoring monarch and other pollinator habitat within and adjacent to agricultural lands throughout the United States.

#### Midwest Row Crop Collaborative

Jonathan facilitated and served as project manager for the Midwest Row Crop Collaborative, a diverse coalition working to expand agricultural solutions that protect air and water quality and enhance soil health while remaining committed to producing enough food to feed the growing global population. The Collaborative's leading companies and conservation groups are all committed to building a broad partnership in three focus states: Illinois, Iowa, and Nebraska. They measure and deliver improved environmental outcomes through cross-sector collaboration and continuous improvement at a meaningful scale throughout the Upper Mississippi River Basin. Jonathan managed several of the Collaborative's work streams, including efforts to engage farmers in practices that improve water quality, communicate farmer efforts to consumers, and educate ag retailers in the economic benefits of sustainability practices. ## Colorado Water and Growth Dialogue

Jonathan facilitated and provided project support for the Colorado Water and Growth Dialogue. By 2030, Colorado is projected to experience a 65 percent increase in population and with it a substantial increase in demand for water. In a state with limited water, this increase in demand will result in a water supply gap. This impending gap is a well-known and pressing problem for the future of Colorado. Thus far, strategies to address the gap have generally taken three forms: develop new supply and water storage projects; implement reuse projects; and encourage water conservation. The Keystone Policy Center led the Colorado Water and Growth Dialogue in an attempt to explore and demonstrate how the integration of water and land use planning should be utilized to reduce water demand from the development and re-development associated with the projected population increase. ## Carlsbad Resource Management Plan Community Roundtables

The Carlsbad field office of the Bureau of Land Management's Resource Management Plan (RMP) guides the management of 2.1 million acres of public land in Eddy, Chaves, and Lea Counties, New Mexico. The plan guides all management within the planning area for 20-30 years, including what areas

are available for energy development, recreation, and conservation priorities. Keystone facilitated two community roundtables that were designed to enable community members and stakeholders to share perspectives, challenges and opportunities regarding land management in the context of the Carlsbad RMP. Participants included diverse perspectives and interests from oil and gas; agriculture; recreation; local, state, and federal government; conservation and environment; religious leaders; and the local business community. The roundtables resulted in a report summarizing the perspectives of stakeholders in attendance. The report provided a reference to the BLM, community members and stakeholders to use during the subsequent period of public comment and associated deliberations on the RMP. (2018)

#### **Gold Butte National Monument Conservation Partners Planning**

Gold Butte National monument in southeast Nevada was established by presidential proclamation in 2016. The monument covers nearly 300,000 acres of remote and rugged desert landscape and is home to stunning rock art sites and other cultural resources as well as unique plants, wildlife, geology and motorized and non-motorized recreational opportunities. Key questions include how to manage and preserve the monument's resources for the future while enabling and improving the visitor experience. Keystone facilitated two meetings of conservation sector partners to identify common vision and priorities to recommend to the Bureau of Land Management as it develops a management plan for the monument. #### Field to Market: The Alliance for Sustainable Agriculture

Jonathan facilitated and served as project manager for Field to Market, a long-standing collaborative stakeholder organization that began as a Keystone dialogue and represents the U.S. commodity agriculture supply chain. Its members include agricultural producers; agribusinesses; food, restaurant, and retail companies; conservation organizations; universities; and federal agencies. Field to Market develops environmental and socioeconomic indicators to measure the sustainability of U.S. commodity crop production. These indicators process national agricultural statistics into meaningful national reports. They also measure ongoing improvement in cropping systems by means of the Fieldprint® Calculator, a freely available online tool. Jonathan's focus was to build consensus on a verification system for member claims, enabled by Field to Market's standard of continuous improvement in sustainability outcomes. #### Sustainable Agriculture Summit

As project lead, Jonathan facilitated a Planning Committee comprised of national scale agricultural sustainability organizations, which have convened to produce the premier annual event for sustainability in U.S. agriculture. The Sustainable Agriculture Summit convened over 500 representatives spanning the supply chain in commodity and specialty crops, beef, poultry, pork, and diary production. Together they comprise a network capable of taking on the nation's largest natural resource issues.

#### **Desert Landscape Conservation Cooperative**

Jonathan facilitated and offered project support to the Desert Landscape Conservation Cooperative (LCC). The Desert LCC is part of a greater LCC network, a nationwide U.S. Department of Interior initiative involving federal, state, tribal, academic, non-governmental, and private sector stakeholders. LCCs are management-science partnerships for addressing climate change and other stressors at a landscape scale. Since 2010, Keystone helped launch four LCCs — the Desert, Southern Rockies, Great Plains and Gulf Coast Prairie — assisting them in establishing their steering committees and identifying science priorities. ## **USDA Forest Service Planning Rule Advisory Committee**

As a subcontractor to Kolibri Consulting Group, Jonathan offered project support and facilitation for the federal advisory committee convened to offer recommendations for the U.S. Forest Service 2012 National Planning Rule and its policy directives. As the rule's directives went into effect, Jonathan assisted and coordinated the committee's efforts to develop guidance supporting the rule's implementation. As a truly cross-sector and inter-governmental group, the committee also assists the Forest Service to establish partnerships and government-to-government relationships to share information and effort across jurisdictional lines.
